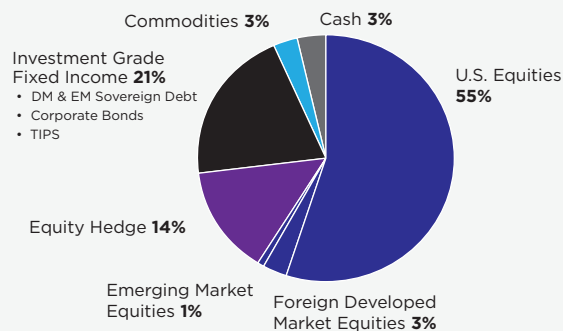
Investment Objective

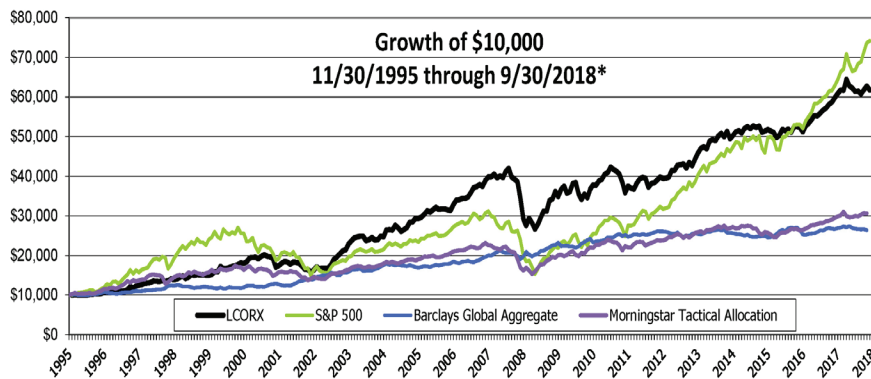

Third Quarter Performance Positives

- As with the second quarter, solid gains in the long-equity exposure were attained from allocations in the Health Care sector, including Managed Health Care, Health Care Facilities, and Health Care Services.
- In a reversal of the prior quarter's dynamics, the Fund's lack of exposure to the Energy sector was beneficial as Energy stocks underperformed in the third quarter.
- Despite a broadly strong stock market, the Fund's equity hedge outperformed its benchmark by a wide margin, losing less than one percent during the last three months.

Third Quarter Performance Detractors

- As a whole, the Fund's long-stock exposure had poor relative results; the subset trailed the S&P 500 by close to 300 basis points.
- While relative performance within the equity hedge position has improved, short-selling was not a winning approach and the position detracted from gains achieved by the stocks held long.

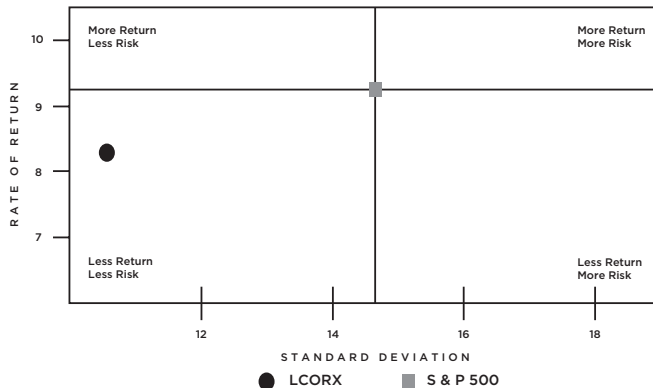

¹Morningstar Ratings™: Overall Rating derived from a weighted average of the performance associated with the 3-, 5-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% 3-year rating (for 36-59 months of total returns), 60% 5-year rating/40% 3-year rating (for 60-119 months of total returns), or 50% 10-year rating/30% 5-year rating/20% 3-year rating (for 120+ months of total returns). While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent 3-year period has the greatest impact because it is included in all three rating periods.
